Schu will repair or replace at its option, any part of the warranted product found to be defective within the terms of the warranty. Schu will not pay for any unauthorized returns or charges for labor, freight, etc. without written permission from Schu.

This warranty does not apply to failures resulting from user modification, attachments to a product, misuse, accidents, abuse, alternation, damage in transit, or if reasonable and necessary maintenance has not been performed Schu's repair liability shall not exceed the original purchase price. Products repaired under this warranty shall not extend the duration of the warranty.

This warranty is expressly limited to providing replacement parts or repairs for products manufactured by Schu.
